Divorce is probably one of the most traumatic times in any person's life. It involves dealing with financial consequences and contact and residence

issues where children are involved. If a couple can amicably agree on the division of the matrimonial assets without commencing a court action (as my ex-wife and I did it) this has to be the way forward. Not only is it less stressful, you will avoid paying out legal fees, although it is always prudent to have some expert legal input and the benefit of an approved Court Order to prevent problems arising later.

Christmas is also a time when disputes can arise over contact with the children, and going direct to a Barrister can be financially beneficial in resolving such difficulties.

Unfortunately an amicable outcome isn't always possible, meaning a court action will be needed to obtain a final order. So, once the Divorce Petition has been served, next comes the question of financial orders relating to the matrimonial assets - i.e. who gets what? Who keeps the house?; what happens to the pensions/policies etc?; what are the arrangements for the children, etc, etc? Both parties file what is basically a statement of means (Form E) and the matter then comes before the court for a First Directions Appointment and subsequently a Financial Dispute Resolution hearing. Many matters settle at that point, but if necessary can proceed to a final hearing. Ideally, it shouldn't take longer than 12 months to get from the starting point to the finish.

Taking advice direct from a Barrister, the legal expert, as early as possible can have a significantly advantageous effect on the overall outcome of your case. Barristers will give you a realistic assessment of what you can and cannot expect to take out of your marriage. Besides the obvious court representation, Barristers can write letters on your behalf to your spouse's lawyer and quite often their very involvement can help to keep a lid on matters.
